ESTABLISHMENT ORDER NO. 01/2016 DATED 05.01.2016

Shri Ravindra Bhokrikar, Inspector of Central Excise (in the common cadre of Bhopal/Jabalpur/Indore/Gwalior/Raipur/Bilaspur/Nagpur-I/Nagpur-II/Audit-I Bhopal/Audit-II Bhopal and Audit Nagpur Commissionerate) is hereby promoted to the grade of Superintendent, Central Excise, Group 'B' in the pay band of Rs.9300-34800 (+) grade pay Rs.4800/- with immediate effect.

- 02. The officer if already been given the benefit of $1^{st} / 2^{nd} / 3^{rd}$ financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
- 03. The above promotion will be subject to outcome of decisions pending in various judicial for a including decisions pending in W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No. 201/00097/14 dated 16.9.2014 filed by Shri Sandeep Karnik & Ors. before the Hon'ble CAT, Jabalpur and WP No. 7092/14, filed by Shri Rajkumar Jain & Ors. before the Hon'ble MP High Court, Jabalpur.
- 04. The Scheduled Tribe status of certain officers who are promoted under challenge in WP NO.2592/2011 (Stamp No.3005/2011) pending in Hon'ble Mumbai High Court Bench at Nagpur. The promotion of above mentioned candidates will, therefore, be subject to the outcome of this WP.
- 05. Under the provisions of FR 22(I)(a)(1), the promoted officer have to exercise his option for fixation of pay within one month of his promotion. He may further note that no request for condonation of delay in exercising the option shall be entertained.
- 06. The Commissioner concerned shall ensure that if the officer above is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.

Transfer and Posting:

- 07. Consequent upon the promotion of Shri Ravindra Bhokrikar to the grade of Superintendent, he is hereby posted to Nagpur Zone.
- 08. The specific postings within the jurisdiction of the Nagpur Zone will be made by the Chief-Commissioner, Nagpur Zone, Nagpur. While doing the posting, it shall be ensured that the existing policy of rotation to sensitive and non sensitive places shall strictly adhered to.

- 09. The officer should ensure proper take over and hand over of charge. List of all urgent and time bound maters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014
- 10. The officer mentioned above must be relieved immediately and he must join at his new place of posting on or before 19.01.2016 under intimation to this office. No representations whatsoever shall be entertained before he join at his new place of posting. The respective Commissioner is requested to submit joining/relieving report of the above officer to this office by 22.01.2016.
