6.2 Information/Complaint can be filed to any authorities of CGST/SGST. It can be filed in format AE-1

6.3 As per CGST Act, 2017 every supplier who collect tax should deposit the same to the Government account. He is also requested to file invoice wise details of supplies in GSTR-1 every month. If any supply escapes GST, it can be verified from the returns.
