


3. The specific postings within the jurisdiction of the Commissionerate will be made by the jurisdictional Principal Commissioner/ Commissioner. While doing the postings, it shall be ensured that the existing policy of rotation to sensitive and non-sensitive places shall be adhered to.

4. The concerned officer should ensure proper take over and hand over of charge. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG (Trg-Ref) dated 26.09.2014.

5. While doing posting, it shall be ensured that the officers (whose names have figured above) who are not clear from vigilance angle, should not be posted to a sensitive charge as per vigilance policy.

6. This issues with the approval of the Pr. Chief Commissioner, Customs, CGST & Central Excise, Bhopal Zone.


