Subject: 'Review of mechanisms to ensure probity among Government Servants' – regarding.


Instructions have been issued from time to time on the need for periodical review of performance of Government servants with a view to ascertain whether a Government servant should be retained in service or prematurely retired from service, in public interest, under the provisions of FR 56(j), FR 56(l) and Rule 48(1) (b) of CCS (Pension) Rules, 1972. The instructions issued from time to time by the Department of Personnel & Training are available on web-site viz. <http://persmin.gov.in>.

2. As per DOP&T OM No. 25013/01/2013-Estt.A-IV dated 11.09.2015 (copy enclosed) cases of Government servants covered under FR 56(j), FR 56(l) or Rule 48(1)(b) of CCS (Pension) Rules, 1972, should be reviewed six months before he/she attains the age of 50/55 years, in cases covered by FR 56(j) on completion of 30 years of qualifying service and under FR 56(l)/Rule 48(1)(b) of CCS (Pension) Rules, 1972 as per the following calendar:

Sl. No.	Quarter in which review is to be made	Cases of employees who will be attaining the age of 50/55 years or will be completing 30 years of service qualifying for pension, as the case may be, in the quarter
1	January to March	July to September of the same year
2	April to June	October to December of the same year
3	July to September	January to March of the next year
4	October to December	April to June of the next year

3. It is requested that review may be carried out as per the instructions and schedules on the subject and the report for the quarter July 2016 to September 2016 be sent to this office as per Annexure to this letter by **10th October, 2016** without fail. A copy of this report is also to be sent to ADG (HRM-I), DGHRD, New Delhi for compilation of the information for submission to DoP&T.
